HOME HEALTH ASSESSMENT CRITERIA HOME HEALTH

(1) Documentation in the certifying physician or allowed practitioner 's medical record or the acute/post-acute care facility's medical records (if the patient was directly admitted to home health) or both must be used as the basis for certification of the patient 's eligibility for home health as described in paragraphs (a) (1) and (b) of this section.

Who Can Certify a Patient for Home Health Services? To initially certify a patient for the Medicare home health benefit, a physician must attest that the eligibility criteria are met, including that the F2F encounter was performed by an allowed provider and related to the main reason the patient needs home health services. Additionally, the physician must document the date of the F2F encounter.
